### //MEMORANDUM//

WHEREAS, No.01030561 Rin (GD) Sukanta Das of 3rd Bn TSR was granted 20 days earned leave w.e.f 07-04-2013 to 26-04-2013, but on expiry of the said leave he did not resume in his duty and overstaying from leave w.e.f 27-04-2013 (FN) to till now without any prior permission of the competent authority and several notices have been sent to him to resume his duty immediately, but he neither resumed his duty nor sent any information to this office; and

WHEREAS, remaining overstayed leave without any permission from his competent authority without any reason and sufficient cause is a serious misconduct and breach of discipline of the Rifles on the part of the member of the rifles under the provisions of TSR Act, 1983 and the TSR (DCSC, Etc.,) Rules, 1986; and

WHEREAS, a Departmental Proceeding No. 13/2013 dated 09-09-2013 has been drawn against Rfn (GD) Sukanta Das for the above mentioned misconduct and a memorandum of article of charges vide No. Pers/TSR-3/Estt/SD/01/9324 dated 20-08-2013 were sent at his home addressed through special messenger but no response was given by the individual.

WHEREAS, in response to the notice issued by the Enquiry Officer & Disciplinary authority to No.01030561 Rfn (GD) Sukanta Das at his home address through special messenger, vide notice No.280/TSR-3/E/13 dated 23-09-13, No.307 dated 06-10-13, No.14752-53 dated 07-11-13 & No.369 dated 24-11-13 to appear before him for preliminary hearing neither he appear before the EO nor before the Disciplinary Authority till now. Due to non appearance of the charged official before the EO, the EO conducted enquiry Ex-parte & submitted the findings of the enquiry on 03/03/14 with the opinion that the article of charges as framed against the charged official has been "Proved beyond doubt".

NOW THEREFORE, No.01030561 Rfm (GD) Sukanta Das of 3<sup>rd</sup> Bm TSR is hereby asked through this publication to appear before "The Office of the Commandant, 3<sup>rd</sup> BN TSR," at Bn HQ, Kachucherra within 07 (seven) days from the date of publication of this memorandum in the local dailies. If No.01030561 Rfm (GD) Sukanta Das does not avail himself of this last opportunity and fails to appear before the Commandant, 3<sup>rd</sup> Bn TSR as perinstructions given above, strict disciplinary action will be taken against him as per TSR Act & Rules.
