NOW, THEREFORE, in exercise of power conferred upon me under Rule 105 of the Tripura Motor Vehicle Rules, 1961 read with Sections 110 & 117 of Motor Vehicles Act, 1988, I do hereby specify the One Way/ Parking Zones/No Parking Zones/Right Turn Prohibition.

- One way Traffic Route :-**
 - Sanjib Chowmuhani to Colonel Chowmuhani from 0000 hrs to 11:30 hrs
(For heavy vehicles only)
 - North-Cole to Town Hall
 - Consentment Road to Buddha Mandir.
- Right Turn Prohibition:**
At Gurda Bazar, Pipra-Makor, Buddha Mandir, Colonel Chowmuhani.

3.	a) TRTC to KSM Chowmuhani (both sides) b) Colonel Chowmuhani to S.K. Chowmuhani (both sides)	(No Parking Zone)
