The officers mentioned in this order shall hold full duty charge, subject to the following conditions:

- i. The officer shall not be entitled to any financial benefits, such as extra pay and allowances that are admissible in the higher rank of Inspector.
 - ii. The officer shall be eligible to wear the shoulder badge of the rank of Inspector of Police on his/her uniform.
 - iii. The promotion of the officer in the normal course, as per guidelines, would not be affected, in any way, by the date from which he/she has been allowed to temporarily hold charge in the higher rank.
 - iv. The officer has no criminal case or departmental proceeding pending against him/ her.
3. The holding of full duty charge of Inspector on a temporary basis would not change the inter-se seniority of the officers in the rank of Sub-Inspector of Police (UB/ AB). This would also not affect the procedure followed during regular promotion to the rank of Inspector at a subsequent stage in respect of any officer.
4. While assuming the full duty charge of Inspector, each officer shall submit an undertaking to the PHQ Tripura, through proper channel, stating that he/she shall adhere to the conditions mentioned in Para 2 of this order.
5. If any criminal case or departmental proceeding is instituted subsequently against any officer mentioned in this order, then that individual officer shall cease to hold the full duty charge of Inspector, and he/she shall no longer be eligible to wear the shoulder badge of the rank of Inspector of Police on his/her uniform.
6. The concerned Heads of Offices shall ensure that any In-Charge Inspector should not be entrusted statutory duties which regular Inspectors are to discharge as per any legal provision.
7. This is issued with the approval of the Director General of Police, Tripura.
