Elections - Mode Code of Conduct/ ECI Instructions - GIST

The Model Code of Conduct (MCC) comes into force immediately on announcement of elections. As soon as MCC comes into force, the following provisions of MCC/directions of ECI (Election Commission of India) shall be strictly followed.

Execution of Works/ Implementation of Schemes/ Projects


- Ministers and other authorities shall not sanction grants/ payments out of discretionary funds. Even where such grants/ payments were sanctioned prior to announcement of elections, disbursal of such benefits should be deferred till completion of election process.
- Ministers and other authorities shall not (a) announce any financial grants in any form or any promise thereof; (b) lay foundation stones etc. of projects or schemes of any kind; (c) make any promise of construction of roads, provision of drinking water facilities, etc.
- Announcement of new projects or programme or concessions or financial grants in any form or promises thereof is prohibited. These restrictions will apply to new schemes as well as ongoing schemes.
- 4. A Scheme cannot be announced or inaugurated or otherwise taken up, simply because a budget provision for the Scheme has been made or the Scheme was sanctioned earlier or a reference to the Scheme was made in the Address of the Governor or in the Budget Speech.
- No fresh sanctions for Government Schemes should be made. Review by political executive (Ministers etc.) and processing of beneficiary-oriented Schemes, even if ongoing, should be stopped. No fresh release of funds on welfare schemes and works should be made or contracts for works awarded, including in respect of works under MPLAD, BEUP, etc.
- 6. No new Work Order shall be issued. Even if Work Order was issued prior to announcement of elections, if the work was not actually started in the field before the announcement of election, it cannot be started till completion of the election process. Only in cases where the work had actually started in the field prior to announcement of elections, the same can be continued. There are some relaxations in case of natural calamities.
- 7. The following type of existing works can be continued by the Government agencies without reference to the ECI:

- a. Work-Projects that have actually started on the ground after obtaining all necessary sanctions;
- b. Beneficiary-Projects where specific beneficiaries by name have been identified before coming of the Model Code of Conduct in force;
- c. Registered beneficiaries of MGNREGA may be covered under existing projects. New Projects under MGNREGA that may mandated under the provisions of the Act may be taken up only if it is for the already registered beneficiaries and the project is already listed in the approved and sanctioned shelf of projects for which funds are also already earmarked.
- 8. Since the Model Code of Conduct only permits continuation of projects/ works actually started on the ground, all the Departments are required to draw up a List on all projects/ works which have actually started on the ground and to furnish the same to the Chief Electoral Officer as also the respective District Election Officers (DEOs) within 72 hours of the announcement of Elections. This serves as a reference document in case of complaints/ disputes on this account at a later stage.
- No fresh tenders shall be floated. Tenders that are already floated may be evaluated, but shall not be finalized.
- 10. No signing of MoU or Agreement where Government is a party.
- 11. Area of operation of any existing project/ scheme/ programme cannot be extended or expanded.
- 12. There shall be no bar to the release of payments for completed for completed work, subject to satisfaction of the concerned officials.

Misuse of Office Machinery/ Transfers and Postings of Officers/ Other Matters

- 13. The Ministers shall not combine their official visit with electioneering work and shall not also make use of official machinery or personnel during electioneering work. The Government vehicles, machinery and personnel shall not be used for furtherance of interest of the party in power.
- 14. Official Vehicles cannot be used for electioneering work. 'Official vehicles' includes vehicles of any organization in which public funds, howsoever small a portion of the total, are invested. Ministers are entitled to use their official vehicles only for commuting from their official residence to their office for office work. No Pilot Car, Beacon Lights, Sirens, etc. shall be used, irrespective of whether the visit is private or official.

- 15. Ministers shall not combine their official tours with election work. In fact, no Minister shall undertake an official visit to any constituency for which elections have been announced.
- 16. No Minister will summon any election-related official for any official discussions during the period of elections. Video-conferencing with District officials is also prohibited.
- 17. Rest Houses, Dak Bungalows or other Government accommodation shall not be monopolized by the party in power and such accommodation shall be allowed to be used by other parties in a fair manner. However, no party can be allowed to use such accommodation as a campaign office or for holding any public meeting for the purposes of election propaganda. Rooms shall not be made available for more than 48 hours to any single individual.
- 18. Issue of Advertisements at the cost of public exchequer in the newspapers and other media and the misuse of official mass media during election period for partisan coverage of political news and publicity regarding achievements of the party/ Government in power is prohibited.
- No appointments or promotions in Government/ autonomous bodies, shall be made without prior clearance of the ECI.
- 20. There shall be a total ban on transfers of all officials connected with the conduct of elections. The transfer orders issued in respect of such officials but not implemented till the model code of conduct came into force, should not be given effect to without obtaining specific permission from the Election Commission. In cases where transfer of an officer is considered necessary for administrative exigencies, prior concurrence of the ECI shall be taken.
- 21. All photographs on political functionaries to be removed from official websites within 24 hours. Similarly, all defacements to be removed from Government properties.

Conduct of Officials

- No video conferencing should take place between the Chief Ministers of the States, Ministers and other political functionaries of the Union and State Governments and the officials individually or collectively
- There are restrictions on tours / leave of the officers whose spouses are active in Political arena

MCC on Transfer/Posting

Immediately on announcement of elections There shall be a total ban on the transfer of all officers/officials connected with the conduct of the election. These include but are not restricted to

- The Chief Electoral Officer and Additional/Joint/Deputy Chief Electoral Officers;
- Divisional Commissioners/DEO/RO/ARO & other revenue officers connected with conduct of elections
- Officers of the Police Department connected with the management of elections like range IGs and DIGs, SSP, SP, SDPO, Inspectors, SIs
- The transfer orders issued prior to the date of announcement but not implemented till the time when model code came into effect should not be given effect to without obtaining specific permission from the Commission

Model Code of Conduct on Transfer/posting

- Restriction on transfer of Sector Officers as their knowledge of the terrain of the area in which they are deployed is essential for effective performance of their duty as sector officers
- The copies of the transfer orders issued under these directions shall be given to the Chief Electoral Officers concerned without fail.
- Any officer who is due to retire within coming six months will be exempted from the purview of the above-mentioned directions of the Commission.
- All the officials of the States/UTs who are on extension of service or re-employed in different capacities will not be associated with any election related work except those with the Office of CEOs.
- Officer should not be allowed to continue in the present district if officer is posted in her/his home district or completed three years out of four years in that district.

- Officers/officials against whom Commission has recommended disciplinary action or who have been charged for any lapse in any election or election related work previously may not be assigned any election related duty

Use of Government Guesthouses

Even casual meeting by Members of political parties inside the premises of the Government owned guesthouse etc. are not permitted. (Relevant to police officers also)

Only the vehicle carrying the person allotted accommodation in the guest house and not more than two other vehicles, if used by the person, will be permitted inside the compound of the Guest House (Relevant to police officers also)


Rooms should not be made available for more than 48 hours to any single individual.






Announcement of New Schemes/Works/Payment out of discretionary funds

- Announcement of the following is prohibited:-

38 It may be noted that the common citizens too have been empowered with C-Vigil App that can straightaway upload complaints on violation. Anonymity is also provided under this application and timely action expected which is monitored closely.
