I, Shri Kiran Gita, District Magistrate, West Tripura District am satisfied to declare the following roads/arcas of Agartala town as Parking Zones/No Parking Zones under Agartala Municipality Council for two wheeler/Light Motor Vehicles.

NOW, THEREFORE, in exercise of power conferred upon me under Rule 105 of the Tripura Motor Vehicle Rules, 1901 read with Section 105 & 117 of Motor Vehicles Act, 1988, I do hereby specify the "Paid Parking Zones/Free Parking Zones".
