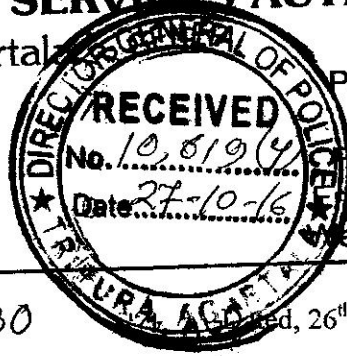

I would like to inform you that the National Legal Services Authority is going to organize two days door to door campaign on 2<sup>nd</sup> and 3<sup>rd</sup> November, 2016 for spreading the legal aid information to the common people of the country. And as a part of the programme it is directed to all the States to take necessary step for successful completion of the campaign on these two days. In our State we have already involved our PLVs to conduct door to door programme in different villages, Ld. Panel lawyers also to conduct similar programme in the courts, the students of Law College in the villages. etc. are to conduct campaign.

As desired by the NALSA in the said programme the involvement of Police Department and other departments would be required so that legal aid information may reach to the common people.
