MEMORANDUM

Publication of notification inviting applications for direct recruitment in various posts through the competitive examinations are being delayed due to pandemic caused by Covid-19 and the aspiring candidates for the posts likely to be advertised by the TPSC or Govt. Departments/ PSUs/ Boards under State Government may meanwhile crossed the prescribed age limit as per the Recruitment Rules.

2. Given under the circumstances, it has been decided by the State Government to relax one year in upper age limit for all categories of candidates (unreserved/ reserved candidates and Govt. servants) against the entry of age limit in respective RRs advertised by the State Government Departments including TPSC/ PSUs/ State Government Organization/ Boards for direct recruitment of various posts.

3. The relaxation of the upper age limit is one time and shall remain in force from the date of issue of this Memorandum till 31st December 2020.
