The substance of the imputations of misconduct or misbehavior in respect of which the inquiry is proposed to be held is set out in the enclosed statement of articles of charge (Annexure – I). A statement of the imputations of misconduct or misbehavior in support of each article of charge is enclosed (Annexure – II). A list of documents by which, and a list of witnesses by whom, the articles of charge are proposed to be sustained are also enclosed (Annexure – III and IV).

- 3. He is informed that an inquiry will be held only in respect of those articles of charge which are not admitted. He should, therefore, specifically admit or deny each article of charge.

Murgavel of "Adm"- Coy,13th Bn TSR (IR-IX) is further informed that if he does not submit his written statement of defense on or before the date specified in Para. 2 above, or does not appear in person before the Enquiring Authority or otherwise fails or refuses to comply with the provisions of Rule 14 of the CCS (CCA) Rules, 1965, or the orders / directions issued in pursuance of the said Rule, the Enquiring Authority may hold the inquiry against him ex-parte.
- 5. Attention of No.06110923 Rfn(GD) P. Murgavel of "Adm"- Coy,13th Bn TSR (IR-IX) is invited to Rule 20 of the Central Civil Services (Conduct) Rules, 1964, under which no Government servant shall bring or attempt to bring any political or outside influence to bear upon any superior authority to further his interest in respect of matters pertaining to his service under the Government. If any representation is received on his behalf from another person in respect of any matter dealt with in these proceedings, it will be presumed that No.06110923 Rfn(GD) P. Murgavel of "Adm"- Coy,13th Bn TSR (IR-IX) is aware of such a representation and that it has been made at his instance and action will be taken against him for violation of Rule 20 of the CCS (Conduct) Rules, 1964.

Murgavel of Adm-Coy, 13th Bn TSR (IR-IX) proceeded to avail 15 (fifteen) days Casual Leave w.e.f.08.01.2016 (AN) to 06.02.2016 (AN) (including 05 days journey period & 01 day transit camp up to Churaibari) but he did not resume his duty on time. According to the preliminary enquiry report submitted by No.85011078 Sub(GD) Birchandra Singh of Adm-Coy, 13th Bn TSR (IR-IX) it is well established that the said Rfn(GD) was overstaying himself unauthorizedly from Casual Leave w.e.f. 07.02.2016(FN) to till date.

He was given 03 (three) notices vide No.1569/F.Pers/TSR-13/Estt/PM/06 dated 19.02.2016, No.2289/F.Pers/TSR-13/Estt/PM/06 dated 10.03.2016, and No.3345 /F.Pers/TSR-13/Estt/PM/06 dated 08.04.2016 directing him to resume his duty but he neither reported nor responded against the notices and remains overstaying from leave to till date, which is an act of prejudicial to good order and discipline of the Rifles U/S 12 (1) of TSR Act, 1983.
