No. <u>08121129 Rfn(GD) Vivek Singh of "D"- Coy</u>,13th Bn TSR (IR-IX) is further informed that if he does not submit his written statement of defence on or before the date specified in Para. 2 above, or does not appear in person before the Inquiring Authority or otherwise fails or refuses to comply with the provisions of Rule 14 of the CCS (CCA) Rules, 1965, or the orders / directions issued in pursuance of the said Rule, the Inquiring Authority may hold the inquiry against him <u>exparte</u>.
- 5. Attention of No. <u>08121129 Rfn(GD) Vivek Singh of "D"- Cov</u>,13th Bn TSR (IR-IX) is invited to Rule 20 of the Central Civil Services (Conduct) Rules, 1964, under which no Government servant shall bring or attempt to bring any political or outside influence to bear upon any superior authority to further his interest in respect of matters pertaining to his service under the Government. If any representation is received on his behalf from another person in respect of any matter dealt with in these proceedings, it will be presumed that No. <u>08121129 Rfn(GD) Vivek Singh of "D"- Coy</u>,13th Bn TSR (IR-IX) is aware of such a representation and that it has been made at his instance and action will be taken against him for violation of Rule 20 of the CCS (Conduct) Rules, 1964.
