**MEMORANDUM**

As per provision laid down in Rule 115 (7) of Central Motor Vehicle Rules (CMVR) - 1989 after the expiry of a period of one year from the date on which the motor vehicle was first registered, every such vehicle shall carry a valid 'Pollution under control' certificate issued by an agency authorized for this purpose by the State Government. The validity of the certificate shall be for (six months) and the certificate shall always be carried in the vehicle and produced on demand by the officers referred to in sub-rule (1) of rule 116:

In compliance to the said provision there are presently 28 nos. pollution testing centre throughout the State.

The enforcement wings of Transport Department including police is vigorously enforcing the various provisions of M.V. Act, 1988 and the CMVR, 1989 in the State for ensuring road safety and public interest.

Compliance of the provision of 115 of CMVR, 1989 is mandatory for all Motor Vehicles including Government and Private Vehicles.

Hence, I am directed to request you to kindly arrange to obtain PUC Certificates for all the vehicles under the control of your Department and direct the drivers to keep the certificate with them while driving.


