Special Summary Revision of Electoral Rolls of all 60(sixty) Assembly Constituencies of the State of Tripura w.r.t. 1st January, 2017 as qualifying date- Posting of Adequate Staff to fill up vacancies & Ban on Transfer/Posting – Sending of Election Commission's directions regarding.

The undersigned is directed to state that the Election Commission of India has announced that the work for undertaking Special Summary Revision of Electoral Rolls of all 60(sixty) Assembly Constituencies of the State of Tripura has started w.r.t. 1st January, 2017.

- In this connection, the Commission has directed that no officials connected with the exercise of Revision of Electoral Rolls like District Election Officers, the Electoral Registration Officers and the Assistant Electoral Registration Officers should be transferred from their places of posting without the prior concurrence of the Election Commission of India. The Commission has also decided that the Booth Level Officers (BLOs) shall not be transferred from their respective places of posting without the prior concurrence of the Chief Electoral Officer. Election Commission has also directed that no officer/officials should be associated with the work relating to or connected with, revision of electoral rolls (i) against whom the Commission has recommended any disciplinary action and the same is pending or (ii) to whom major penalty has been given as a result of said disciplinary proceeding or (iii) against whom a serious criminal case is pending in any court of law or (iv) who was transferred out during any previous revision of rolls or conduct of
