

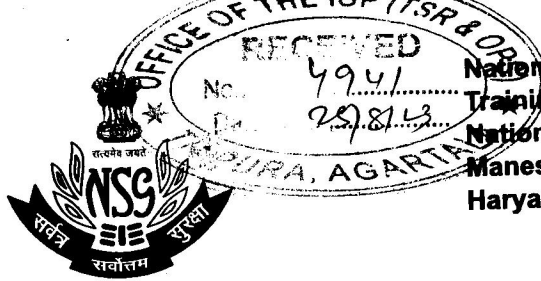

*Dear Sir,*

1. Thus, it is imperative for Security Forces, industries and academia to come and work together to put their experiences and expertise to work out a better solution for the IED challenges posed by the Anti-National Elements. It is appreciated that, the subject award will surely act as a stimulator to encourage the Start-Ups, Scientists, Academicians and other enthusiasts to come up with innovative Counter-IED technology to mitigate the IED menace in the country.

The prime motive of the institution of the award is to identify, felicitate and honour those innovators, including civilians, scientists, personnel working in Central/ State Government departments and Security Forces, who have made outstanding contribution towards innovation in counter-IED fields, including the following specific areas :-  
(a) innovation of Counter-IED equipment/ apparatus, having path-breaking technology, which can help the Security Forces in identification, detection and disposal of IEDs from a safe distance.

(b) Innovation in the field of Synthetic Training Environment (STE)/ development of Virtual Reality (VR) training simulator to facilitate Counter-IED training.


(c) Innovation of drone technology/devices, which can be used for Counter-IED operations, including detection, taking control of and destruction of rogue drones carrying IEDs.
