5. Tender/quotation is liable to be rejected summarily for not fulfillment of any of the condition given below:-

### TERMS AND CONDITIONS

1. No tender/quotation will be accepted without the required amount of Earnest money.
2. Rate(s) offered should be written legibly both in figures and words clearly. Any overwriting/ erasing/ illegible writing will not be allowed and in such it may be rejected.
3. The successful bidder shall have to deposit the entire amount within 07 (seven) days from the date of issue of the acceptance letter through challan in favour of SP (SC). No cash payment will be accepted. The successful bidder should arrange to remove the vehicle within 03 (three) days from the date of depositing the bid money, failing which, Earnest money will be forfeited.
4. GST, if applicable as per rules has to be paid by the successful bidder to the appropriate Taxing authority and the documents of such payment should be submitted to the undersigned within 07 (seven) days from the date of issuance of acceptance of the tender alongwith the Tender value.
5. Earnest money of the successful bidder will not be released till delivery of the condemned vehicles. The EMD of the unsuccessful bidders etc. will be released after the selection of highest bidder.
