NOTICE INVITING TENDER

Sealed Tender are hereby invited by the undersigned on behalf of the Governor of Tripura from the enlisted and bonafied contractors / firms / agencies of Tripura PWD /TTAADC in appropriate class having experiences in similar nature of job for the following works:-

The earnest money and all necessary documents like proof of nationality, Professional Tax clearance Certificates, enlistment of C.E. /S.E/ E.E. of PWD as approved contractor and valid license for engagement of workers in the contract works from the Labour Deptt., Govt. of Tripura is to be submitted along with the tender so as to reach the office of the undersigned on or before **11/07/2022**.

The estimates (Schedule of Rate of works) details tender notice & terms and condition for proposed works can be had from the office of the undersigned on any working day during office hours w.e.f. **18/06/2022 to 11/07/2022**.

4. CONDITIONS FOR VALIDITY OF THE TENDERS

To be valid, the bidder should fulfill the following conditions:-

The tender should be accompanied by:-

- ii) Up to date Professional Tax Clearance Certificates, SGST, CGST, Sale Tax, Income Tax & enlistment of C.E./S.E./E.E of PWD as approved contractor and valid license for engagement of workers in the contract works from the Labour Deptt., Govt. of Tripura.
- (ii) Earnest money Deposit **Rs.1863/-** for Sl No.1 above, **Rs.2493/-** for Sl No.2 above, **Rs.11,886/-** for Sl No 3 above and **Rs.7485/-** for Sl No.4 above mentioned works since the shape of Deposit at Call issued by a nationalized bank having branches in Gomati Tripura District in favour of the Superintendent of Police, Gomati District, Udaipur to be deposited along with the tender, failing which, tender will not be considered to be valid.
- (iii) Rate should be quoted both in words and figures.
- (v) No. price escalation will be allowed till completion of the work.

5. PROCEDURE FOR SUBMISSION OF TENDER:-

Tenders should be sent by Registered / Speed Post / Courier so as to reach the Office of the undersigned on or before **11/07/2022** up to 1730 hrs or the tender should be dropped at **Superintendent of Police (Gomati) Office Tender Box on or before 11/07/2022 up to 1730 hrs.** Tenders received thereafter will not be accepted and no postal delay will also be considered. The tender, which is not valid in all respect and submitted other than the mode as specified above, are liable to be rejected summarily.


6. OPENING OF TENDERS:-

- (iii) The tenders, if possible, will be open on **12/07/2022 at 1200** hours in the office of the undersigned in presence of the tender opening committee and intending tenderers who may like to remain present in person.
- (iv) The undersigned reserves the right to reject or accept any tender including the lowest one without assigning any reason or whatsoever.

4. OTHER TERMS & CONDITIONS:

- (vi) The contractor exempted from earnest money should attach copy of the letter exempting from depositing earnest money issued by the appropriate authority in duplicate unless who have qualified in Engineering degree or any equivalent degree in any discipline may not be exemption. He/she must be submit D/call in the tender.
- (vii) Any correction to rates and items of the tender should be initiated by the contractor. No enhancement over rate once accepted will be allowed for any reason what-so-over.
- (viii) The accepting authority does not bind him self to accept the lowest tender and reserves himself the authority to reject any or all of the tenders received without assignment of reasons. All tenders in which any of the prescribed conditions is not fulfilled **shall be liable** to be rejected.
- (ix) Sales Tax and other taxes on materials in respect of this contract shall be payable by the contractor and Govt. will not entertain any claim what so ever in this respect.
- (x) They will have to be completed within **90 (Ninty days)** and work to be started within **07(Seven) days** from the date of issue of work order otherwise earnest money deposited by the contractor shall be liable to be forfeited to the Govt.
- (vi) No labour under 14(fourteen) years of age shall be employed in the work and all labours employed shall be employed in the work and all labours employed should be paid for similar work in the neighborhood. Fair wage clause introduced by the Govt. of India. Ministry of labour and CPWD contractor's regulations will be binding on the contractors. All tolls and plants and implements required for constructions of the work to be arranged by the contractor.
- (xxvi) Before submitting tender, the tenderers are to satisfy themselves by actual visit to the site of works as regards the prevailing conditions of approaches and roads and availability of labourers and materials etc. and the tenderers submitting tender shall be deemed to have done so. No claim on the above amount will be entertained afterwards.
- (xxvii) No transfer of earnest money from the amount already at the credit of Tenders (as Earnest Money or security deposit in connection with other work) will be allowed unless however, it is absolutely free for any order for its release has been passed.
- (xxviii) It will be obligatory for the contractor to produce forest clearance certificate from the DFO having jurisdiction over the area in respect of extraction of any forest produces for utilization in the work under this contract before final payment and or refund of security deposit, if the contractor fails to do so, the amount of royalty to be given to Forest Department will be deducted from the bill of the contractor and the same will be deposited to relevant head of the Forest Deptt.
- (xxix) The tender of the work shall not be witnessed by a contractor or contractors who. Himself / themselves has / have tendered or who has / have tendered for the same work. Failure to observe this condition should tender / tenders of the contractor(s) as well as witnessing the tender liable to summary rejection.

- (xxx) Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the tenders who will resort canvassing will be liable to rejection.
- (xxxii) The location of the work shall be as per approved lay out plan.
- (xxxiii) SGST, CGST, Sale Tax which is applicable and Income Tax (2%) shall also be deducted at source from the bills of the contractor.
- (xxxiiii) 1 % (one percent) cess on constructional works (at source) will be deducted from the bill as per provision of Building and others workers welfare cess Act, 1996.
- (xxxv) Cement and any other item issued will be ISI marked and the best quality.
- (xxxvi) All GI and CI pipes and structure fixing or the beam, purline, rafters king, post should bear ISI mark with superior quality and finished surface.
- (xxxvii) Payment will be made on completion of 100% work and on realization of bill from Govt. Treasury.
- (xxxviii) The contractor must submit attested copy of his enlistment of C.E./S.E./E.E. PWD as approved contractor of Tripura.
- (xxxix) No materials shall be supplied by this unit for the said construction work.
- (xl) Construction shall be done strictly on enclosed estimate and drawing as well.
- (xli) The work will be supervised by on officer of this unit or Engineer of PWD of Tripura, or Asstt, Engineer, Police Engineering Cell, PHQ, Tripura Agartala.
- (xlii) Tenders which do not fulfill any of above terms and conditions or are incomplete in any respect, are liable to summarily rejection.
- (xliii) Bills in duplicate to be submitted by the successful tenderers after completion of the work duly certified by the competent authority through the supervision officer of this unit for arranging payment subject to proper verification of bill and M.B. by the appropriate authority.
- (xliv) The earnest money deposits of the unsuccessful tenders will be refunded after finalization of the tenders.
- (xlv) The successful tenders shall have to furnish Security Money @ 10% of the work order value in shape of Deposit at call in favour of Superintendent of Police (Gomati), Udaipur or any Nationalized Bank having branches at Udaipur within **07(Seven) days** from the date of issue of work order failing which the earnest money deposit will be liable to be forfeited to State Govt. The earnest money deposit of the successful tenderers may also be converted in to part of security money if the tenderer so desires in writing.
- (xxvi) No non Indian national as laborer who does not posses valid passport and visa will be allowed to work under any contractor or otherwise contract will be cancelled and there is no bar by police for prosecution of the contractor along with their laborers.
- (xxvii) Contractor will have to be responsible for shortage or wastage of department materials issued to the contractor.
- (xxviii) The work to be completed as above, and to be started within 05(Five) days from the date of issue of work order other wise earnest money deposited by the contractor shall be liable to be forfeited to the Govt.
- (xxix) The tenders containing uncalled for remarks or additional conditions are liable to summarily rejection.
- (xxx) Photographs of the works should be obtained in three stages – i.e. before, during and after execution of the work at the cost of the executing agency and the same should be enclosed along with bills for each stage 2(two) copies.
- (xxxi) The work should be completed by the Agency within the stipulated period of time. Other wise levy for non completion of the work in time will be imposed as per PWD rule /circular.
- (xxxii) No running bill will be allowed in any case.
