// NOTICE //

WHEREAS, No. 02010609 E/F (Cook) Anukul Debnath, 1st Bn TSR absented himself from BN HQR, Gokulnagar, Sepahijala Tripura from 29.01.2020 without prior permission.

AND WHEREAS, the following 04(four) notices were served to him to his home address to resume duty, but he neither reported nor intimated this office for his such prolong absence from duty.

- i) Notice No. 1 vide this notice No. 1178-79 dated 12.02.2020.
- ii) Notice No. 2 vide this notice No. 1536-37 dated 28.02.2020.
- iii) Notice No. 3 vide this notice No. 2378-79 dated 04.04.2020.
- iv) Notice No. 4 vide this notice No. 2572-73 dated 21.04.2020.

AND WHEREAS, as per the Tripura State Civil Services(Leave) Rules,1986 he should to produce the Medical Certificate by an authorized Medical practitioner in case of genuine illness.

AND WHEREAS, Sri Sukanta Debnath son of E/F (Cook) Anukul Debnath reported that his father did not go their home and as such he also made a GD Entry at Bishalgarh Police Station on 02.02.2020.

AND WHEREAS, a preliminary enquiry was conducted vide this office order No. F pers/TSR-1/AD/02/Estt/2020/2834 dated 11.05.2020 and it was established that E/F (Cook) Anukul Debnath left the HQR, location 1st Bn TSR, Gokulnagar, Sepahijala, Tripura on 29.01.2020 at 1800 hrs voluntarily.

AND WHEREAS, the status report of missing of No. 02010609 E/F (Cook) Anukul Debnath, 1st Bn TSR was sought from OC Bishalgarh PS, Sepahijala and Baikhora PS, South Tripura vide letter No. pers/AD/TSR-1/Estt/2021/4420-22 dated 28.06.2023 by this office.

AND WHEREAS, OC Jolaibari Outpost, intimated vide No. 1675 dated 19/09/2023 through OC Baikhora PS that nobody was able to say the present location of missing person namely Sri Anukul Debnath.

AND WHEREAS, subsequently another enquiry was conducted vide order No. 241/TSR-1/Enquiry//22/8788 dated 13.10.2023 and it is transpired from the report that he is found absent from Bn HQR, on 29.01.2020 at 1800 hrs without any valid permission of the authority and he may be missing from that day.

AND WHEREAS, the matter has been brought before the notice of AIGP(Crime), PHQ vide this office letter No. pers/TSR-1/AD/02/Est/2021/10542 dated 09.12.2023, seeking decision of the competent authority whether the absence from duty from such a long period to be treated as 'Deemed Resignation' w.e.f. 29.01.2020 or otherwise.


AND WHEREAS, the following views of Law Department Govt. of Tripura has been conveyed by PHQ vide No. U.O 10/DGP/LC/2024, dated 03.01.2024 to this office.

"There is no ambiguity in the provision of 11th Amendment of TSCS(Leave) Rules, Though there is another clarification Memo from the GA(P&T) Department.

So, the Deptt. may take necessary action to invoke the relevant provision of the Rules, if it exactly fit for the unauthorized absentee

AND WHEREAS, the Dy. Secretary, Home Department, Govt. of Tripura conveyed above opinion, now therefore, No. 02010609 E/F (Cook) Anukul Debnath, 1st Bn TSR is hereby asked to show-cause as to why he should not be treated as 'Deemed Resigned' from Govt. service for willful, un-authorized and continuous long absence w.e.f 29.01.2020 to till date i.e about 04 years.

He is hereby given an opportunity to submit representation or if he so desires, he can appear before the undersigned personally within 15(fifteen) days positively from the date of publication of the notice in daily newspapers. If he fails to reply or appear in person with stipulated time, it will be presumed that he has no further representation and necessary order regarding his 'Deemed Resignation' will be passed by the undersigned.
