Notification


Reference is made to the Office Memorandum No.33-4/2015-NDM-I dated 20th March, 2015, issued by the Ministry of Home Affairs (DM Division), Government of India (GOI) regarding salient recommendations of 14th Finance Commission in respect of providing relief assistance from State Disaster Response Fund (SDRF) to the victims of State-specific Disasters within the local context in the State.

2. As per recommendation, expenditure for providing immediate relief to the victims of State -specific disasters within the local context in the State, which are not included in the GOI notified list of disasters eligible for assistance from SDRF/NDRF, can be met from SDRF within the limit of 10% of the funds available under SDRF, provided the State has formally listed the State-specific disasters for inclusion and notified transparent norms and guidelines with a clear procedure for identification of the beneficiaries for disaster relief for such local disasters, with the approval of the State Executive Committee.

3. Now, as per approval of the Council of Ministers and Chairman of the State Executive Committee, the Revenue Department hereby notify the '**Lightning / Thundering**' as the State-specific Disaster for the State of Tripura.

4. The list of items and norms of assistance for providing relief to the victims of the aforesaid State-specific disaster from SDRF shall be the same as applicable for GOI notified list of disasters.

5. This will come into force with immediate effect.


