## **NOTIFICATION**

WHEREAS, No. 91010681 Hav(GD) Prasenjit Singha Barua of 8<sup>th</sup> Bn TSR (i) while detailed to perform the duty of unit Canteen NCO, 8<sup>th</sup> Bn TSR(IR-III) has allegedly involved himself in gambling and fraudulently collecting money from TSR personnel of 8<sup>th</sup> Bn TSR(IR-III) by showing or announcing or advertising secretly one Radioactive coin saying that the coin will be sold to other foreign country and in turn hundred time more money will be given back to all the investors (ii) while detailed to perform the duty of Canteen NCO, 8<sup>th</sup> Bn TSR(IR-III) (Liquor/CSD) vide order No. F.08/TSR-8/Estt/ORD/13/1173-83 dated 07<sup>th</sup> February' 2015, he failed to maintain cash and cash book, physical stock and stock ledger of liquor fund with actual position of fund resulting in huge discrepancy, revealed during the audit conducted by PHQ audit team;

AND WHEREAS, this office has initiated a departmental Proceedings vide No.F.08/TSR-8/Estt/ 16/13299-300 dated 14/09/2016 and No.F.08/TSR-8/Estt/16/17684-86 dated 02/12/2016;

AND WHEREAS, the Enquiry Officer of the D.P also served several notices through Officer-In-Charge, Kanchanpur PS, North Tripura directing him to appear before the EO for preliminary hearing and submission of his defence statement and obtained his signature but despite receiving all the notices, neither he appeared before the EO nor intimated anything;

NOW THEREFORE, the appointing authority for the purpose of giving an opportunity before taking departmental action against No. 91010681 Hav(GD) Prasenjit Singha Barua of 8<sup>th</sup> Bn TSR notifies this notification in local daily news papers for appearance of No. 91010681 Hav(GD) Prasenjit Singha Barua of 8<sup>th</sup> Bn TSR, S/O-Shri Prakash Kusum Barua, Vill-Subhasnagar, PO-Kanchanpur, PS-Kanchanpur, North Tripura before the Enquiry Officer in his office chamber at Bn HQr, Lalcherra within 15 days from the date of publication of this notification in local news paper, failing to avail this last and final opportunity ex-parte decision will be taken against him as per TSR Act & Rules.
