The Government in GA (P&T) Department aims to build Executive Record Sheets for the Tripura Civil Service, Tripura Police Service & Tripura Forest Service Officers.

In view of this, information and data capture of the Officers in Executive Record Sheets portal are essential. The data of the officers will be collected through crowd sourcing i.e. the officer concerned will feed his/ her own data in the portal. The portal is already live and the address is www.ers.tripura.gov.in.

In order to access and register in the portal for Executive Record Sheet, all such officers must have their personal government email ID (@nic.in/ @gov.in).

Considering this and the policy as applicable to all employees of Govt. of India and employees of State/UT Governments to use the e-mail services as per "E-mail Policy" of Department of Electronics & Information Technology, Ministry of Communication & Information Technology, Government of India, it is imperative for all the TCS/TPS/TFS Officers to have their personal government email ID.

Therefore, all the Departmental Heads and Secretaries of the Commissions/ Boards/ Societies under the Government of Tripura are hereby requested to suitably direct the TCS/TPS/TFS Officers serving under their establishments/ departments to open email ID and to feed their data/ information in the www.ers.tripura.gov.in latest by 31st December 2018.

The matter is most urgent.


