

2. All concerned are requested to send nomination of an eligible officer(s) **by 15.07.2018** through their respective Competent Authorities [**State Govts./UT Govts. in case of officers of States/UTs**] for the captioned Interpol visit on the E-mail stated above, keeping in view all the guidelines stated in latest circular of Department of Expenditure, Ministry of Finance (Office Memorandum No. 4(4)/ E.Coord/2015 dated 05.01.2016) before finalizing his/her name.

2 It is requested that the work experience of the nominated officer in relation to the subject matter along with no. of visits made by him/her during the last three years must be reflected/explained may also be send along with the nominations.

3. If the officer nominated is an IPS officer, his/her batch year along with respective state cadre should clearly be mentioned in the proposal sent . If not, cadre and vigilance clearance must be provided alongwith the proposal.

4. It is time and again seen that nominations received in this Ministry from the various States/UTs/Organizations/Departments do not come with the approval of respective Competent Authorities [**State Govts./UT Govts. in case of officers of States/UTs**] and this leads to unnecessary delay in completing all the formalities before finally processing the matter for NOC of Union Home Secretary. The same may please be avoided.
