## NOTICE INVITING TENDER

Sealed tenders are invited by the undersigned on behalf of the Government of Tripura from the bonafide suppliers/resourceful manufactures/dealers for supply and installation of 01(one) Water Cooler for Crime Branch Office, Agartala.

# Condition for the validity of the tenders :-

The tender should be accompanied by :-

- i. The necessary documents like GST Registration/PAN Card & Firm Registration Certificate, etc. are to be submitted along with the bid.
- ii. Rate should be quoted both in words & figures, GST & other transportation charges, if any, may be indicated separately.
- iii. The earnest money to be deposited of Rs 2,000/- (Rupees two thousand) only of the total tender value in the shape of deposit at call issued by a Nationalized Bank having Branch at Agartala in favour of Deputy Inspector General of Police(Crime Branch), Tripura, Agartala-799001 to be deposited along with technical bid, failing which tender will not be considered to be valid.

#### 3. Procedure for submission of the Tender:-

Tender should be sent by registered/speed post/courier so as to reach to the office of the Supdt. of Police(Anti Narcotics), A.D.Nagar, Agartala, Tripura(w), Pin-799003, o/o the DIGP(Crime Branch), Tripura on or before **05-01-2022 up to 1600 hrs** or may drop in the drop box at the office of the Supdt. of Police(Anti Narcotics), Office of the Dy.Inspr. Genl. of Police(Crime Branch), Tripura. Tenders receipt after specific date & time will not be accepted and no postal delay will also be considered. Tenderers may drop the tender in the sealed tender box at the office of the Supdt. of Police(Anti Narcotics) under the DIGP(Crime Branch), Tripura.

#### 4. Opening of Tenders :-

- i. The tender will be opened on **05-01-2022 at 1700 hrs** by the Committee at the office of the Supdt. of Police(Anti Narcotics), A.D. Nagar, Agartala in presence of the parties who may like to be remained present.
- ii. The undersigned reserves the right to reject or accept any tender including the lowest one without assigning any reason what so ever.

### 5. Responsibility of the successful Tenders :-

The successful tender shall have to:-

- i. Supply and install the item in the Crime Branch Office building as per the specifications and other criteria mentioned in the Tender Notice. The tenderer shall have to take back the rejected article/s, if any at his own cost & supply replacements for the same within such extended period as may be indicated by the undersigned.
- ii. The decision of the authority whether the supplied material/s have matched with the approved specification or not & whether the extended delivery period is adequate or not, shall be final.

#### 6. Penalties.

The supply order will be cancelled in case of failure to supply within the stipulated period/extended delivery period given by the undersigned without assigning any reason. Tenderers shall have to Supply, Install and Commissioning the item/s in the Crime Branch Office building within the stipulated time given by the undersigned.

#### 7. Miscellaneous.

- i. Cost of the item is including of all taxes, transportation, installation and commissioning.
- ii. No advance payment will be made. The payment will be made by the office of the undersigned after completion of Supply, Installation, Commissioning & acceptance of the item by the accepted Committee constituted by the competent authority.
- iii. The earnest money of unseccessful tenderer shall be refunded after finalization of tender.
- iii. Warranty period of the item/s to be supplied should be indicated & necessary documents are required to be submitted along with the bid.
- iv. The supplier should provide the user Manual & Guarantee/Warranty card along with the item/s which should be handed over to the Committee at the time of installation of the same.
- v. Delivery shall be made within 15 to 21 days after receipt of the supply order. Supply should be made at the Office of the undersigned. Extension for delivery is to be given after obtaining competent authority approval, if required.
