Sealed tenders are invited by the undersigned on behalf of the Government of Tripura from the bonafide suppliers/resourceful manufactures/dealers for installation of Network connectivity for crime Branch, New Building at Old Secretariat Complex, Agartala. Condition for the validity of the tenders:-

The tender should be accompanied by:-

i. Earnest money to be deposited Rs. 1500/- (Rupees One Thousand Five Hundred) only of the total tender value in the shape of deposit at call issued by a Nationalized Bank having branch at Agartala in favour of Supdt. of Police (SC & EO) Tripura, Agartala, PIN: - 799003 to be deposited along with technical bid, failing which tender will not be considered to be valid.

ii. Rate should be quoted both in words & figures, GST & other transportation charges, if any, may be indicated separately.

Procedure for submission of the Tender:-

Tender should be sent by registered/speed post/courier so as to reach the office of the undersigned on or before **25.04.2021 up to 1600 hrs.** or may drop in the drop box at the office of the undersigned. Tenders receipt after specific date & time will not be accepted and no postal delay will also be considered. Tenderers may drop the tender in the sealed tender box in the office of the undersigned in sealed cover.

4. Opening of Tenders:-

- i. The tender will be opened on 25.04.2021 at 1700 hrs. By the committee in the office of the undersigned at A.D. Nagar, Agartala in presence of such parties who may like to remain present.
- ii. The undersigned reserves the right to reject or accept any tender including the lowest one without assigning any reason what so ever.

5 Responsibility of the successful Tenders:-

The successful tender shall have to:-

- i. Installed the items in the Crime Branch building as nper specifications for establishing network connectivity. The tenderer shall have to take back the rejected articles, if any at his own cost & supply replacements for the same within such extended period as may be indicated by the undersigned. The decision of the authority whether the supplied materials have matched with the approved specification or not & whether the extended delivery period is adequate or not, shall be final.

6. Penalties

The supply order will be cancelled in case of failure to supply within the stipulated period/extended delivery period given by the undersigned without assigning any reason. Tenderers shall have to install the items in the Crime Branch building so as to set up networking connectivity in all tree floors of the building.

7. Miscellaneous.

- i. Cost includes installation online & basic operation/demonstration of the devise, as required
- ii. The earnest money of unsuccessful tenderer shall be refunded after finalization of tenders.
- iii. The payment will be made by the office of the undersigned after completion of works & acceptance of the same by the accepted committee constituted by the competent authority
- iv. Warranty period of the items to be supplied should be indicated & necessary documents are required to be submitted along with the bid.

v. The supplier should provide the user manual & guarantee/warranty card alongwith the item's which should be handed over to the committee at the time of installation of the same.

vi. No interest will be allowed on the earnest money/security deposit.

vii. No advance payment shall be allowed.
