

NOTICE INVITING TENDER

The undersigned on behalf of Government of Tripura invites sealed cover quotation from bonafide Suppliers/Firms for supply of Stationery items & Binding, Re-Binding of Book/ Register, for the year 2022-2023 for use of the West District Police. Items are indicated in the Annexure A,B&C. The sealed cover containing quotation for purchasing of the articles should reach to the Office of the undersigned on or before 15.00 hrs. — on 10-06-2022 and the tender will be opened on the same day at 16.00 hrs, if possible.

The Terms and condition for the firms/contractors for submitting quotation for the Annual Tender for the year 2022-2023 are as under:-

Firms who are willing to submit tender should furnish earnest money of Rs.6,000/- (Rupees Six thousand) only for each of the Annexure-A & B for Rs.2000/- (Rupees Two thousand) only Annexure C. The earnest money of the successful quotationer will be treated as security money automatically & the earnest money of the unsuccessful quotationers will be released after finalization of quotation. The earnest money is to be Bank Draft or Deposit at Call drawn by Bank having a branches at Agartala in favour of the Supdt. of Police(West), Tripura, Agartala. Cash or Cheque will not be accepted. The earnest money will be released after completion of tender period and completion of supply of articles with satisfaction of the competent authority.


All firms/contractors shall have to submit their tender together with a attested photo copy of PAN card, GST Registration, Trade license, Income Tax & GST clearance of current validity without which no tender shall be accepted.

The bidders should be quote the rate of store article including Tax & GST against each item with in-words in prescribed forms which may be collected from West District Police Forms & Stationery store, A.D.Nagar, Police line, Agartala, West Tripura.

Parties shall be selected separately for each item on the basis of the lowest rate and other valid considerations. Defective or incomplete quotations in any respect shall not be considered. One rate should be quoted for every article both in figure and in words in terms of Rupees and Paisa only. The quoted rates shall remain operative up to March 2023.

All the suppliers should complete supply of item(s) as per specification as accepted on tender within 7(seven) days from the date of receipt of supply order and failing which the supply order should be treated as cancelled. And the earnest money of the firms/contractors will be forfeited. Payment will be made after completion of supply as per availability of fund.

The undersigned reserves the right to accept or reject any quotation either in whole or in part, including the lowest rates without assigning any reason thereof.
