TERMS & CONDITIONS FOR VALIDITY OF THE TENDERS

- (A) The Tender should be accompanied by:-
- (i) PAN Card, Aadhaar Card, up to date ALL TAX (Sale Tax, Income Tax & Professional Tax) Clearance Certificate, Trade License/ Firm's Registration, GST Registration, Forest Clearance certificate in regard to the supply of forest goods and Bank details.
