- 02. The earnest money and all necessary documents like proof of Nationality, Professional Tax/Income Tax/Sale Tax clearance certificate, PAN Card, Registration of GST, enlistment certificate of PWD etc. as approved contractor and valid license for engagement of workers in the contract works from the labour department Govt. of Tripura are to be submitted along with the tender so as to reach the office of the undersigned by 1600 hrs on 04.01.2024.
- 03. The tender/quotation will be received in the office of the undersigned from 1100 hrs to 1600 hrs on any working day up to <u>04.01.2024</u>. The tenders/Quotations will be opened on <u>05.01.2024</u> at <u>1700 hrs</u> in the presence of representative of the Tenderers willing to remain present at the time, if possible.

### 04. OTHER TERMS AND CONDITIONS:

- (i) Tenders can be sent through Registered post/ Speed post or dropped in the tender Box of the office of the Commandant, 6<sup>th</sup> Bn TSR (IR-II), Ramchandraghat, Khowai Tripura within the last date of receipt of the tenders i.e. <u>04.01.2024</u> upto <u>1600 hrs</u> and same will be opened on <u>05.01.2024</u> at <u>1700 hrs</u>. The tenders shall be opened by the board of officers as nominated by Commandant, 6<sup>th</sup> Bn TSR(IR-II), Ramchandraghat, Khowai Tripura in presence of intending tenders who may desire to be present at <u>1700 hrs on 05.01.2024</u>, if possible.
- (ii) The tender of the contractors who do not deposit the Earnest Money in the shap of 'D' call in favour of the Commandant, 6<sup>th</sup> Bn TSR(IR-II) on any Nationalized Bank will be summarily reject.

- (iii) Tenders shall be placed in sealed covers with the name of work written on the top of the envelops for each separately.
- (iv) No Extension of time for submitting tender beyond mentioned date will be given.
- (v) The contractor should quote rates in figures as well as in words including all charges/Taxes/Rents/duty and transportation charges etc.
- (vi) Any correction on rates in the tenders should be initialed by the contractor before dropping of the tender only. No enhancement/over rate once accepted will be allowed for any reason whatsoever.
- (vii) The accepting authority does not bind himself to accept the lowest tender and reserve himself the authority to reject any or all of the tenders received without assigning any reasons. All tenders in which any of the prescribed conditions is not fulfilled shall be liable to be rejected.
- (viii) Copy of NIT, Terms & conditions and specifications etc. must be submitted alongwith the tenders duly signed by the contractor.
- (ix) The contractors must submit their TCC(PTC), VAT registration Certificate, PAN Card, forest Clearance Certificate, Registration of GST, Enlistment of C.E/S.E.E, PWD as approved contractors of Tripura, license regarding engagement of workers in the contract works from Labour Department, Govt. of Tripura.
- (x) GST and other Taxes on materials in respect of this contract shall be payable by the contractor and Govt. will not entertain any claim whatsoever in this respect.
- (xi) The work is to be started within 07(Seven) days from the date of issue of work order and work will have to be completed within time as mentioned in the NIT against each of work, otherwise earnest money deposited by the contractor shall be liable to be forfeited to the Govt.
- (xii) No labour under 14(fourteen) years of age shall be employed in the work and all labours employed should be paid at rates not less then those generally paid for similar works in the neighborhood. Fair wage clause introduced by the Govt, of India, Ministry of labour and CPWD contractor's regulations will be binding on the contractors.
- (xiii) All tools and plants and implements required for the construction of the works to be arranged by the contractor.
- (xiv) Before submitting tender, the tenderers are asked to satisfy themselves by actual visit to site of work regarding the prevailing conditions of approaches and roads and availability of labourers and materials etc. and the tenderers submitting tenders shall be deemed to have done so. No claim on the above account will be entertained afterwards.

(xv) It will be obligatory for the contractor to produce Forest Clearance Certificate from the DFO having jurisdiction over area in respect of extraction of any forest products for utilization in the work under this contract before final payment and or refund of security deposit, if the contractor fails to do so, the amount of royalty to be given to Forest Department will be deducted from the bill of the contractor and the same will be deposited to relevant head of the Forest Deptt.

(xvi) No transfer of Earnest Money from the amount already at the credits of tenders (as earnest money or security deposit in connection with the other work) will be allowed.

(xvii) The Tenders for the work shall not be witnessed by a contractor or contractors who himself/ themselves has/ have tenders or who may has/have tendered for the same work. Failure to observe this condition as well as witnessing the tender will be liable for rejection summarily.

(xviii) Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the tenders who will resort to canvassing will be liable to be rejected.

(xix) The location of th work shall be as per approved lay out/estimate.

(xx) GST, Income tax and Labour Cess shall also be deducted at source from the bills of the contractor as per existing provision of the State Govt.

(xxi) Cement and any other items used will be ISI marked and of the best quality.

(xxii) Payment will be made on completion of 100% work and on realization of bill from Govt. Treasury.

(xxiii) The contractor must submit attested copy of his enlistment C.E/S.E/E.E/PWD as approved contractor of Tripura.

(xxiv) No materials shall be supplied by this unit for the said construction work.

(xxv) Construction works shall be made strictly on enclosed estimate and drawing as well.

(xxvi)The work will be supervised by an Enginner, Police Engineering Cell, PHQ.

(xxvii)Bill in triplicate to be submitted by the successful tenderers after completion of the work along with measurement book duly certified by the competent authority through the supervising officers for airangement payments, subject to proper verification of bills and MB by appropriate authority.

(xxviii) The earnest money deposited by the unsuccessful tenderers will be refunded after finalization of the tender process.

(xxix) The successful tenderers shall have to furnish 'Security Money' @10% of the work order value in the shape of 'Deposit- at- Call' in favour of the Commandant, 6<sup>th</sup> Bn TSR(IR-II) on any Nationalized Bank having branches at Khowai within 07(seven) days from the date of issue of work order failing which the earnest money deposited will be liable to be converted into part of security money if tenderers so desires in writing.

(xxx) No foreigner as labour who does not possess valid passport and visa will be allowed to work under any contractor or otherwise contract will be cancelled and there is no bar by police for prosecution of contractors along with their laboures.

(xxxi) Letters etc. found in the tender box of raising or lowering the quoted rates or dealing with any other points in connection with tender shall not be considered.

(xxxii) The undersigned reserves right to cancel work order if it is not completed by the contractor for execution within the stipulated period as mentioned in the work order.

(xxxiii) On receipt of work order, the undersigned along with the Engineer who has prepared the respective estimate, the concerned unit/Sub-unit in-Charge and the contractor will visit work site and the contractor will be briefed about the requirement of work, Necessary photography will be taken by contractor about the existing position of the work before taking its work as per NIT and similarly on completion of the work and in running stage of the works. Phtograph of such will be taken by the contractor. In no any circumstances the contractor shall start the works without joint visit of the team of officers and contractor mentioned.

(xxxiv) 03(three) stage photographs of works i.e. before, during and after execution of the work and work completion certificate duly signed by executive engineer or Assistant Engineer of Police Engineering Cell, PHQ Tripura should be submitted alongwith Bill and MB duly signed by supervising officer of Police Engineering Cell, PHQ, Tripura.
