- 9. The contractor must submit attested copy of his/her enlistment of C.E./S.E./E.E. PWD as approved contractor of Tripura.
- 10. No materials shall be supplied by this unit for the said construction work.
- 11. The work will be supervised by an officer of this unit or Engineer of PWD Tripura or Asstt. Engineer, Police Engineering Cell PHQ, Agartala.
- 12. Construction shall be done strictly as per specification of estimates.
