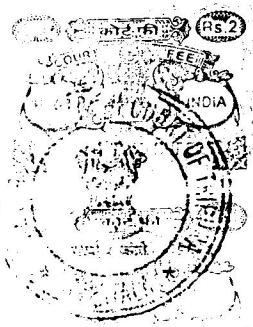
Heard Mr. Somik Deb, learned counsel appearing for the petitioner as well as Mr. J. Majumder, learned counsel appearing for the respondents.

According to Mr. Somik Deb, learned counsel appearing for the petitioner due to advertence, the name of the petitioner's father has been written as Bakul Debnath in the cause title of the writ petition and for that reason even in the cause title of the judgment, the father's name of the petitioner has been typed as "Bakul Debnath" whereas the name of the father of the petitioner is "Sri Chittaranjan Debnath".

That apart, Mr. Deb, learned counsel appearing for the petitioner has pointed out that in Para-18 the number of the writ petition as filed by the petitioner has not been incorporated inadvertently though in the main file, the writ petition is shown to be allowed for his appointment being prior to 01.01.1996.

Mr. J. Majumder, learned counsel appearing for the respondents has fairly submitted that he does not have any objection to the correction as initiated

In view of that, in the cause title of the writ petition being WP(C) No. 526 of 2016 the father's name of the petitioner stands corrected as "Sri Chittaranjan Debnath" in lieu of "Bakul Debnath". Similarly, in the cause title for the said writ petition being WP(C) No. 526 of 2016 [appearing at Page-3 of the common judgment and order dated 20.02.2017] the father's name of the petitioner shall be corrected from "Bakul Debnath" to "Sri Chittaranjan Debnath".

Registry shall make the necessary correction, for purpose of record, both in the judgment and in the writ petition by virtue of this order. It appears that inadvertently, the number of writ petition as filed by the petitioner being WP(C) No. 526 of 2016 has not been incorporated in Para-18 of the said common judgment and order. As such, at Page-102 of the said common judgment and order, in Para-18, after WP(C) No.525 of 2016, the following entry shall be inserted by way of incorporation: "WP(C) No. 526 of 2016".

Registry shall also make the necessary correction in the manner as stated above. However, as a measure of abundant caution, this order shall form part of the said common judgment and order dated 20.02.2017.
