ELIGIBILITY CRITERIA FOR DEPUTATION OF INSPECTOR IN CBI

As per the Recruitment Rules of CBI, the eligibility criteria for induction of Inspectors on deputation are as under:

1. The Officer must be a graduate from a recognized University.
2. Officers of Central or State Police forces or Armed Forces holding analogous posts on regular basis in parent cadre/department or with five years of regular service in the grade of Sub-Inspector of Police in the pay band-2 Rs. 9300-34800/- plus grade pay of 4200/-.
3. Officer must have 05 years experience.

The official joining on deputation in CBI are entitled to receive the following incentive packages:

1. Special Security Allowance @ 20% of basic pay
2. Cash Compensation for working on Saturday/holiday @ 2 ½ days for every completed month of service subject to a maximum of 30 days in a year.
3. Medical facilities and Children Education Allowance as per the rules of Central Government.
