Sealed Tender are hereby invited by the undersigned on behalf of the Governor of Tripura from the enlisted and bonafied contractors / firms / agencies of Tripura PWD /TTAADC in appropriate class having experiences in similar nature of job for the following works:-

All necessary documents like proof of nationality, Professional Tax clearance Certificates, enlistment of C.E. /S.E/ E.E. of PWD as approved contractor and valid license for engagement of workers in the contract works from the Labour Deptt., Govt. of Tripura is to be submitted along with the tender so as to reach the office of the undersigned on or before **05/10/2024 upto 1600 hours**.

1. CONDITIONS FOR VALIDITY OF THE TENDERS:-

To be valid, the bidder should fulfil the following conditions:-

The tender should be accompanied by:-

- i) Up to date Professional Tax Clearance Certificates, SGST, CGST, Sale Tax, Income Tax & enlistment of C.E./S.E./E.E of PWD as approved contractor and valid license for engagement of workers in the contract works from the Labour Deptt., Govt. of Tripura for the Assessment Year 2024-25.
- (ii) The Tender's rate should be quoted against each item both in figures and words.
- (iii) No price escalation will be allowed till completion of the work.
- (iv) The venders will have to submit visible video footage for full period of hiring of installation of cameras in all locations to concerned SDPO's and obtain visual video footage certified copy from the concerned SDPO's & submit the same with the bills.

2. PROCEDURE FOR SUBMISSION OF TENDER:-

Tenders should be sent by Registered / Speed Post / Courier/by hand so as to reach the Office of the undersigned on or before **05/10/2024 upto 1600 hours**. or the tender should be dropped at **Superintendent of Police (Gomati) Office Tender Box on or before 05/10/2024 upto 1600 hours**. Tenders received thereafter will not be accepted and no postal delay will also be considered. The tender, which is not valid in all respect and submitted other than the mode as specified above, are liable to be rejected summarily.

3. **OPENING OF TENDERS:-**

- (i) The tenders, if possible, will be open on **05/10/2024 at 1700** hours in presence of the tender opening committee and intending tenderers who may like to remain present in person.
- (ii) The undersigned reserves the right to reject or accept any tender including the lowest one without assigning any reason or whatsoever.

4. **OTHER TERMS & CONDITIONS:**

- i) Sales Tax and other taxes on materials in respect of this contract shall be payable by the contractor and Govt. will not entertain any claim what so ever in this respect.
- ii) No labour under 14(fourteen) years of age shall be employed in the work and all labours employed shall be employed in the work and all labours employed should be paid for similar work in the neighbourhood. Fair wage clause introduced by the Govt. of India. Ministry of labour and CPWD contractor's regulations will be binding on the contractors. All tolls and plants and implements required for constructions of the work to be arranged by the contractor.
- iii) Before submitting tender, the tenderers are to satisfy themselves by actual visit to the site of works as regards the prevailing conditions of approaches and roads and availability of labourers and materials etc. and the tenderers submitting tender shall be deemed to have done so. No claim on the above amount will be entertained afterwards.
- iv) The location of the work shall be as per approved lay out plan.
- v) SGST, CGST, Sale Tax which is applicable and Income Tax (2%) shall also be deducted at source from the bills of the contractor.
- vi) Payment will be made on completion of 100% work and on realization of bill from Govt. Treasury.
- vii) No materials shall be supplied by this unit for the said work.
- viii) Tenders which do not fulfil any of above terms and conditions or are incomplete in any respect, are liable to summarily rejection.
- ix) Bills in duplicate to be submitted by the successful tenderers after completion of the work duly certified by the competent authority through the supervision officer of this unit for arranging payment subject to proper verification of bill etc. by the appropriate authority.
