


The earnest money and all necessary documents like attested copies of Nationality, professional tax-clearance-certificates, PAN card, enlistment of CE/SE/EE of PWD as approved contractor and valid license for engagement of workers in the contractor works from the Labour Deptt., Govt. of Tripura are to be submitted along with the tender so as to reach the office of the undersigned on or before **10/03/2025 up to 1300 hrs.** The tenders will be opened on the same day at 1300 hrs. if possible in the office of the undersigned in presence of the intending tenderer who may like to remain present in person.

TERMS AND CONDITIONS

- Any collection of rates and items in the tender should be initiated by the contractor. No enhancement over rate once accepts will be allowed for any reason what-so-ever.
- The accepting authority does not, bound himself to accept the lowest tender and reserves himself the authority to reject any or all of the tenders received without assignment of reasons. All tenders in which any of the prescribed conditions is not fulfilled shall be liable to be rejected.
- Sale Tax and other Taxes on materials in respect of this contract shall payable by the contractor and Govt. will not entertain any claim what so ever in this respect.
- The work will have to be completed within stipulated period and to be started within 7(seven) days from the date of issue of work order otherwise earnest money deposited by the contractor shall be liable be forfeited to the Govt.
- Before submitting tender, the tenderers are to satisfy themselves by actual visit to the site of works as regards the prevailing conditions of approaches and roads and availability of labours and materials etc. and tenderers submitting tender shall be deemed to have done so. No claim on the above amount will be entertained after wards.
- Sale Tax, Income Tax, & labour cess shall also be deducted at source from the bills of the Contractor as per provision rules.

7. The contractors must submit documents attested copy of his/her PAN card, Labour licence and Tax Clearance certificate with validity.
8. Payment will be made on completion of 100% work and on realization of bill from the Govt. Treasury.
9. The contractor must submit attested copy of his/her enlistment of C.E./S.E./E.E. PWD as approved contractor of Tripura.
10. No materials shall be supplied by this unit for the said construction work.
11. The work will be supervised by an officer of this unit or Engineer of PWD Tripura or Asstt. Engineer, Police Engineering Cell PHQ, Agartala.
12. Construction shall be done strictly as per specification of estimates.
13. Tenders which do not fulfill any of above terms and conditions or are incomplete in any respect, are liable to summarily rejection.
14. Bill to be submitted by the successful tenderers after completion of the work duly certified by the competent authority through the supervision officer of his unit for arranging payment subject to proper verification of bill and M.B by the appropriate authority.
15. The earnest money (to be deposited in the shape of Deposited at Call issued by a bank having branches at Khowai in favour of the Superintendent of Police, Khowai District Tripura) deposits of unsuccessful tenders will be refunded after finalization of the tenders.
16. Photograph of the works should be obtained in three stages -i.e. before, during and after execution of the work at the cost of the executing agency and the same should be enclosed along with bills.
17. No running bill will be allowed in any case.
