**NOTICE INVITING TENDER**





**TERMS AND CONDITION FOR VALID OF TENDER FOR SUPPLY OF ARTICLES**

01. Sealed cover tender (Technical bid and Commercial bid to be given in separate sealed covers) are invited by the undersigned on behalf of the Governor of Tripura from the bonafied suppliers/manufactures/registered firms for supply of gymnasium equipments in favour of 5<sup>th</sup> Bn TSR (IR-I), Duluma, Amarpur, Gomati, Tripura for the year 2024-25 covering the period up to 31<sup>st</sup> March'2025.

02. Details of required store articles and stationery items are mentioned in the separate sheet. The tender should be accompanied by.

(a) Up-to- date GST registration certificate and Firm's Registration Certificate.

(b) Earnest money @**2.5%** of estimated value shall be deposited in the shape of "**DEPOSIT-AT-CALL**" issued by a Nationalized Bank having branches in India in favour of the Commandant, 5<sup>th</sup> Bn TSR(IR-I), Duluma, Amarpur, Gomati, Tripura along with the Technical bid. The tender without earnest money shall summarily be rejected.

(C) Rate should be quoted both in figures and in words. GST and Transportation charges if any, may be indicated separately and only one rate should be quoted for each items, otherwise tender will not be considered.

(d) **Rate should be quoted inclusive of all taxes, shipping charges and installation charges.**

(e) Selected items should be shipped at HQr 5<sup>th</sup> Bn TSR, Daluma, Amarpur, Gomati Tripura PIN-799101.

(f) Tender will not be considered to be valid, if technical bid and commercial bid are not submitted in separate sealed cover.

(g) Tenderer will be selected not only based on the lowest quoted rate(s) but also the requisite quality/specification of the items and other facility(warrantee/Guarantee etc.) provided by supplier.

(h) Supplier will be responsible for the breakage/damaged and loss occurs in transit on the way to destination.

(i) The tender shall be selected separately for each item on the basis of the lowest rate and other valid consideration as per terms & conditions, experience etc.

03. **PROCEDURE FOR SUBMISSION OF TENDER:**

(a) Tender should reach to the office of the undersigned on or before 1300 hrs on **17.03.2025** Envelope containing the tender should be sealed and super scribed on the

top as **"TENDER FOR SUPPLY OF STORE ARTICLES & STATIONERY ITEMS FOR 5<sup>TH</sup> BN TSR"**.

(b) The technical bid and commercial bid should be submitted separately in separate envelopes, both of which should be then inserted in another envelope which should be then sealed and super scribed as mentioned in (a) above. The technical and commercial bids should also be sealed and super scribed on the top as **"TECHNICAL BID FOR SUPPLY OF STORE ARTICLES & STATIONERY ITEMS FOR 5<sup>TH</sup> BN TSR and "COMMERCIAL BID FOR SUPPLY OF STORE ARTICLES & STATIONERY ITEMS FOR 5<sup>TH</sup> BN TSR"**.

**04. OPENING OF TENDERS:**

(a) The technical bid of the tender will be opened on **17.03.2025 at 1600** hrs at the office of the undersigned in presence of such parties who may like to remain present. Commercial bids of the tenders will be opened only whose technical bids are qualified.

(b) Parties shall be selected separately for each item on the basis of the lowest rate and other valid and the undersigned reserves the reserve the right to reject or accept any tender including the lowest one without assigning any reason whatsoever.

**05. RESPONSIBILITY OF THE SUCCESSFUL TENDERER:**

The accepted rates shall remain valid up to 31<sup>st</sup> March' 2025 from the date of quotations. The successful tenderer shall have to deliver goods for which supply order is placed & supply to be completed within stipulated period as mentioned in the supply order and supply should be as per specifications. The tenderer shall take back the rejected articles, if any, at his own cost and replacement of the same within such extended period as may be indicated by the undersigned. The decision of the authority whether the supplied materials have matched with the approved specifications or not and whether the extended delivery period is adequate or not shall be final.

**06. PENALTIES:**

The supply order will be cancelled in case the tenderer fail to supply within the stipulated period or extended delivery period if any given by the undersigned and the security deposit shall be liable to be forfeited.

**07. MISCELLANEOUS:**

(a) The earnest money of the un-successful bidder shall be refunded after finalization of tender.


(b) The payment will be made by the consignee, Commandant, 5<sup>th</sup>Bn TSR (IR-I) through beneficiary account after completion of supply and acceptance by Survey Committee constituted by the competent authority.

(c) Necessary documents are required to be submitted along with the technical bids.

(d) No interest will be allowed in the earnest money/security deposit.

(e) No advance payment shall be made.

(f) All the valid firm required to submit GST bill.
