TERMS AND CONDITION FOR VALID OF TENDER

- 1. Tenderer shall have to submit separately photocopies of all relevant documents like Trade License, GST Registration, Income Tax returned 2023-2024, PAN card, Aadhaar card, Bank* account details, Beneficiary code or beneficiary details on prescribed form duly filled-up & signed, along with tender in support of his/her/their legal and valid competency as tenderer.
- "EARNEST MONEY" separately (i) Rs.5,000/- only for supply of Store Items (ii) 2. Rs.3,000/- only for Office Stationery items (iii) Rs.3,000/- only for Motor Transport (MT) spare parts as well as Job works is to be furnished along with tender in the shape of "DEPOSIT-AT-CALL" (Bank Draft only) issued by a Nationalized Bank having branches in India in favour of the Commandant, CIAT School, Tripura, Kachucherra Dhalai. - 6. The quoted rates shall be deemed to have been offered for the financial year 2025-2026 covering period upto 31 March 2026 inclusive GST, Income Tax, Service charge, transportation charges etc.
