Subject :- Recruitment of Constables of Tripura Police on compassionate appointment (Die-in-harness scheme)

In pursuance of Government of Tripura, Home Department letter No. F.1(76)-PD/2018/1281 dated 23.04.2025, 13 candidates (Men – 08 (SC – 02, ST – 06 & UR – NIL) and Women – 05 (SC-NIL, ST - 02 & UR – 03) as noted in Annexure – 'A' are approved for appointment as Constable of Tripura Police on compassionate ground (Die-in-harness scheme) temporarily under KTDS PTA, Narsingarh.

The Offer of appointment will be issued by Principal, KTDS PTA, as per notification of the GA(P&T) Department vide No. F.1(1)-GA(P&T)/2018 dated 03.09.2019 which shall be made twice in a year i.e 1st January and 1st July of the year. If the dates itself falls on Govt. holiday then the appointment will be on the following working day after observing all due formalities. Their medical examination may be conducted at the KTDS PTA by authorized Medical Officer. Their C/A verification may be conducted through concerned OC PSS. After appointment, the medically fit provisionally selected candidates will undergo basic training under KTDS PTA, Narsingarh.
