TENDER NOTICE

The undersigned on behalf of Governor of Tripura invites sealed cover quotations from the bonafied suppliers/ Firms for supply of store articles as indicated vide Annexure-A, B, C & D in sealed covers containing quotations for purchasing of store articles should reach to the office of the undersigned on or before 15.30 hrs. on **25/06/2025** at the SP (W) office, near Fire Brigade Chowmuhani, Akahura Road, Agartala, West Tripura and the tender will be opened on the same day at 16.00 hrs. if possible in presence of the representatives of the willing firms/suppliers. List of store articles are available in the store for free of cost.

The terms and condition of annual tender for the Financial year 2025-26 are given below :-

Firms who are willing to submit their quotation on tender notice should furnish earnest money of Rs.6,000/- (Rupees six thousand) only separately for each of the Annexure-A, B, C, & D. The earnest money is to be send in the form of Bank Draft/Deposit at call drawn from any Nationalized Bank in favour of the undersigned, cash/cheque or N.S.C will not be accepted.

The earnest money of the successful firms refuses to supply of store articles at their own cost within stipulated period after final selection of quotation will be forfeited to the state. The earnest money of the successful tenders will be released after completion of supply at the end of financial year 2025-26.

All firms shall have to submit their tender together with a copy of Trade License, PAN Card, GST Registration, Current Income Tax clearance, etc. without which any tender shall not be accepted.

Defective or incomplete quotations in any respect shall not be considered. One rate should be quoted for each article both in figure and words in terms of rupees and paisa only.

Sample of specifications shall have to be send for inspection as per list. The rejected samples should be collected by the firms at their own cost from the store immediately after finalization of the quotation. Even, the lowest rate will not be accepted without sample and **as per current market price**. The earnest money of the firms whose tender are not accepted will be returned.


All supplies should be completed within 7(seven) days from the date of receipt of supply order, otherwise supply order will be treated as cancelled without any prior notice. Payment will be made after completion of supply only as per availability of fund.
