- Earnest money Deposit for Rs.2545/- only in the shape of Deposit at Call issued by bank having a branches at Agartala in favour of the Supdt: of Police(Proc), Tripura payable at Agartala to be deposited along with the tender, failing which, tender will not be considered to be valid.

- iv) Rate should be quoted both in words and figures.
- v) No price escalation will be allowed till completion of the works.

## 2) PROCEDURE FOR SUBMISSION OF TENDER.

Tender should be sent by Registered/Speed Post/Courier so as to reach in the Office of the undersigned on or before 11/09/2025 up to 1600 hrs or may be dropped in the tender box in the office of the undersigned. Tenders received thereafter will not be entertained and no postal delay will also be considered. No tender will be accepted by hand. The tender should be Sealed and super scribed on the top as Maintenance of office of the DIGP(S/Range) at PHQ complex, Agartala due on 11/09/2025.

- The tenders, which is not valid in all respect and submitted other than the mode as specified ii) above, are liable to be rejected summarily.
- OPENING OF TENDERS 3)
- The tenders, if possible, will be opened on 11/09/2025 at 1700 hrs, in the office of the i) undersigned in presence of the intending bidders who may like to remain present in person.
- The undersigned reserves the right to reject or accept any tender including the lowest one. ii) without assigning-any-reason-or whatsoever.
- OTHER TERMS & CONDITION. 4)
- The contractor exempted to deposit earnest money should attach copy of the letter -i}-exempting from depositing earnest money issued by the appropriate authority in duplicate.
- Any correction to rates and items in the tender should be initiated by the contractor before ii) dropping the tender only. No enhancement over rate once accepted will be allowed for any reason whatsoever.
- No interest will be allowed on the earnest money/ security deposit. iji)
- The accepting authority does not bind him to accept the lowest tender and reserves him the iv) authority to reject any or all of the tenders received without assigning any of reasons.
- All tenders in whom any of the prescribed condition is not fulfilled shall be liable to be v) reiected.
- Sales Tax and other taxes on materials in respect of this contract shall be payable by the vi) contractor and Govt. will not entertain any claim what so ever in this respect.
- The above mentioned work will have to be completed within 45(forty five) days and to be vii) started within 7(seven) days from the date of issue of work order otherwise security money deposited by the contractor shall liable to be forfeited to the Exchequer Govt.
- No labour under 14(Fourteen) years of age shall be employed in the work and all labours viii) employed should be paid at rates not less than those generally paid for similar work in the neighborhood. - All tools and implements required for construction of the work to be arranged by the ix) contractor.

- xvi) Payment will be made on completion of 100% work and on realization of bill from the Govt. Treasury after submission of final bill duly certified by Engineer of Police Engineering Cell, PHQ.
- xvii). No materials shall be supplied by this unit for the said construction/repairing works.
- xviii) Construction/repairing shall be done strictly on enclosed estimate and drawing
- xix) The work will be supervised by Engineer of Police Engineering Cell, PHQ, Tripura, Agartala.
- xx) Tenders which do not fulfill any of above terms and conditions or are incomplete in any respect, are liable to summarily rejected.
- xxi) Bills in triplicate to be submitted by the successful bidder after completion of the work duly certified by the competent authority through the supervision officer of this unit for arranging payment subject to proper verification of bill and M.B. by the appropriate authority.
- xxii) The earnest-money deposits of the unsuccessful bidder's will be refunded after finalization of the tenders.
- The successful bidder shall have to furnish Security Money @ 5% (five percent) of the work order value in the shape of Deposit at call in favour of Supdt. of Police (Procurement),

  Tripura payable at Agartala from any Bank having branches at Agartala within 07(Seven) days from the date of issue of work order failing which the deposited Security money will be liable to be forfeited to Exchequer Govt. the earnest money deposit of the successful tenderer may also be converted into part of security money if the bidder so desires in writing.
- xxiv)—No non Indian national as labourer who does not possess valid passport and visa-will be allowed to work under any contractor or otherwise contract will be cancelled and there is no bar by police for persecution of the contractor along with their labourers.
- The work to be completed as above, and to be started within **07(Seven)** days from the date if issue of work order otherwise earnest money deposited by the contractor shall be liable to be forfeited.
- xxvi) The tenders containing uncalled for remarks or additional conditions are liable to summarily rejection.
- xxvii) No advance payment should be allowed.
- xxviii) Photographs of the works should be obtained in three stages i.e. before, during and after completion of the works along with authentication by the supervising officer and the same should be enclosed along with the final bill.

In no circumstances the contractor shall start the works without joint visit of the team of office and the contractor as mentioned.
