
SHORT TENDER NOTICE

The Undersigned on behalf of the Governor of Tripura invited sealed cover quotation from bonafide vehicle owner for hiring 01 (one) No. of Light Motor Vehicle (Bolero) for Cyber Crime Police Station for the period of 01(one) year under Tripura Police Crime Branch. The quotation should reach to the office of the undersigned on 12-09-2025 from 1100 hrs to 1600 hrs and quotation will be opened on the same day at 1700 hrs if possible in presence of the tenderer who may like to be present.

The tender will be covered by following Terms & Condition


1. The vehicle has to be provided with your own driver with valid driving license.
2. Registration of the vehicle should be commercial not before the year 2020.
3. The vehicle should be in good condition with valid vehicle fitness certificate, Tax Clearance certificate, Valid pollution certificate etc.
4. EMD of Rs.10,000/- is to be submitted with the tender in the shape of deposit at call in favour of SP(Serious Crime) from any nationalized bank having Branch in Agartala. No tender without deposit at call as stated will be considered valid and such tender will summarily be rejected and no correspondence in this regard will be entertained. The earnest money deposited along with the tender shall be converted as security money if the tender is finally accepted.
5. EMD of the unsuccessful Tendered will be released on finalization of the Tender.
6. No interest will be allowed for the EMD.
7. If the Tendered is exempted from any of above, proper documents in this regard is required to be submitted along with the Tender.
8. Sealed Tender should be superscribed as "TENDER NOTICE FOR PROVIDING HIRING VEHICLE-FOR-CYBER CRIME-POLICE-STATION"
9. All cost towards running of vehicle i.e cost of lubricants, maintenance, repairing and pay & allowance of driver etc. will have to be bear by the owner of vehicle. The fuel issued from SP (Procurement) PD Pump.
10. Necessary of Taxes like, Income Tax and GST will be detected as per applicable rate from the bill.
11. Rate: - As per Delegation of Financial power Rules-2019, Finance Department Govt. of Tripura.
12. Necessary bill must be submitted in triplicate quarterly to MTO (TPCB) by the concerned owner of vehicle along with Log Book for payment. Copy of PAN CARD and ADHAR CARD should also be submitted along with the bill.

The defective or incomplete quotation in any respect shall not be considered. One rate should be considered. Vehicle should place in the M.T Section, TPCB, Old Secretariat Agartala, Tripura(West) within 02 (Two) days from the date of received of the office order on acceptance.
