## TERMS AND CONDITION

- 1. Details of the estimate & specification of the work is available in the office of the undersigned for inspection on any working days during the office hours.
- 2. Earnest money Deposit as mentioned above in the shape of Deposit at Call issued by the bank having branches at Agartala in favour of the Tripura Police Crime Branch to be deposited along with the tender, failing which tender will not be considered to be valid.

- 3. The following documents should also be accompanied with the quotation without which no quotation will be considered.
  - (i) An attested copy of enlistment certificate issued by the E.E/S.E/E.E PWD as approved contractor of Tripura.
  - (ii) Professional Tax clearance /GST clearance certificate / IT clearance certificate of current validity.
  - (iii) Self attested copy PAN Card / ADHAR card.
  - (iv) Self attested copy of Bank details (account No/IFSC Code/ MICR code etc)
- 4. Tender should be submitted on a non-judicial stamp paper in format No.F/TRI-7(seven).
- 5. Earnest money deposit(EMD) of the successful bidder will be released on receipt of security deposit @ 5% of the work order value in favour of the undersigned within 07(seven) days from the date of issue of work order failure which EMD is liable to be forfeited to the Government Account. Earnest money of unsuccessful Tenderer will be released after finalization of quotation.
